# **Terms of Service**

Welcome to any.market! These Terms of Service ("Terms") govern your access to and use of any.market website, platform, and related services (collectively, the "Services"). Please read them carefully.

# 1. Acceptance of Terms

By accessing or using the Services, you agree to these Terms and our Privacy Policy. If you disagree, you may not use the Services.

# 2. Changes to Terms

We reserve the right to update these Terms from time to time. Changes will be effective when posted with a new "Last Updated" date. Your continued use of the Services after changes are posted indicates your acceptance of the updated Terms.

# 3. Eligibility

You must be at least 18 years old and legally capable of entering into binding contracts to use the Services.

# 4. Accounts and Security

#### **Account Creation**

When you create a store or make a purchase, an account will be created automatically for you. By creating or using an account, you agree to provide accurate information.

### **Account Security**

You are responsible for:

- · Maintaining the confidentiality of your account credentials
- All activities that occur under your account
- Notifying us immediately of any unauthorized access to your account
- Keeping your account information accurate and current

- Continues to function even if you disconnect your GBP

# **Google Business Profile Connection**

- You can disconnect your GBP anytime via myaccount.google.com/permissions

We do not maintain permanent copies of raw Google Business Profile API data.

We access and collect the following GBP data with your explicit consent:

- Menu data, including sections, items, descriptions, and prices

- Verification status

#### How We Use Your GBP Data

- To create your any.market online store with optimized, structured content
- To add your store link to your Google Business Profile at initial store creation only (only with your explicit prior consent)
- To generate AI-enhanced descriptions, content recommendations, and menu optimizations
- To display your business information accurately on your storefront

**Important:** We make **no subsequent changes** to your Google Business Profile after initial store creation.

# **Data Ownership and Control**

- You retain full ownership of all your Google Business Profile data and Al-transformed derivative content
- We do not sell, rent, lease, or share your GBP data with third parties for their marketing purposes
- We will not use your GBP data for purposes other than providing the Services as described
- You may revoke our access to Google Business Profile at any time via your Google Account settings

#### **Customer-Generated Content**

We access **customer reviews and ratings** about your business through the Google Business Profile API. These reviews are:

- Created by customers who did not directly authorize any.market
- Accessed only as permitted by Google APIs under Limited Use requirements
- Used solely to display customer feedback in your store
- Not used for advertising, AI training, or any other purpose
- Handled with the same security standards as your business data

#### **Google API Compliance**

- any.market's use of information received from Google APIs will adhere to the Google API Services User Data Policy, including the Limited Use requirements.
- We adhere to all Google Business Profile API policies and guidelines
- We implement appropriate security measures to protect your GBP data

#### **Third-Party Management (if applicable)**

If you use any.market to create stores for other businesses:

- You represent and warrant that business owners have authorized you to initiate OAuth on their behalf
- · Business owners must authorize access through Google's OAuth consent flow
- The OAuth consent screen clearly shows what data will be accessed
- Authorization is required before any profile data is retrieved
- We add the store link to their Google Business Profile only at initial store creation (with their explicit consent)
- No subsequent changes are made to their Google Business Profile after creation

We grant you a limited, non-exclusive, non-transferable, revocable license to access and use the Services for their intended purpose, subject to these Terms.

### **Google Branding**

You must comply with Google's branding guidelines when displaying any Google-related features, buttons, or content in connection with your use of the Services.

#### 11. Indemnification

#### Informal Resolution

Before filing a claim, you agree to contact us at info@any.market to attempt to resolve the dispute informally. We will try to resolve conflicts in good faith within 30 days.

#### **Class Action Waiver**

To the extent permitted by law, all claims must be brought in the parties' individual capacity and not as a class member in any purported class, collective, or representative proceeding. You agree to waive any right to participate in any class action lawsuit or class-wide arbitration.

#### 15. Modifications to the Services

We reserve the right to:

- Modify, suspend, or discontinue the Services (or any part thereof) at any time
- Impose limits on certain features or restrict access to parts of the Services
- Change pricing for paid features with 30 days' advance notice
